Progress on a New Hubbell Genealogy

The volume of information available since the publication of the 1995 Additions and Revisions to History and Genealogy of the Hubbell Family has greatly enhanced the knowledge about our family. In order to share this information a new history and genealogy is in preparation. The Genealogy Committee explored ways to avoid renumbering the entire data base but was unable to find a simple, logical system that would keep the old numbers and allow insertion of new information. Several possible improvements became evident as we started the process of incorporating the new information and renumbering. We believe these changes will enhance the usefulness of the new genealogy. These changes are:

- 1. Dates have been changed to the more modern style of day month year. This change will eliminate the need for commas and end confusion between numerals for both days and months.
- 2. Beginning with the 6th generation everyone will receive a unique whole number eliminating the alphabetical supplements and roman numerals. This will provide a more uniform appearance and help eliminate confusion. The decision not to go back and change the first 5 generations was made because those generations were already processed and relatively little new information was added.
- 3. The new numbers will be followed by the 1995 numbers in parentheses. It is necessary to include the 1995 numbers since the stored data at the Hubbell Library references the 1995 numbers. Information that has been reported in the Annual and Family Notes with interim numbers will not be tracked in the new genealogy. The new complete index should provide the necessary access.
- 4. The index will be as follows: surname, first name, middle initial or name, birthdate in order with the oldest date first. This will greatly assist researchers especially for the more common first names.

We have become comfortable with our "Hubbell" numbers and the committee regrets the changes. It should be mentioned that even to this day, the genealogy committee receives communications with the 1980 numbers and has little difficulty in identifying the referenced person(s). A briefing is being prepared for the 2015 reunion and proposed publication dates will be announced at the reunion.



From Your Editor

This years Annual is focused on our English Heritage. As you are all aware, the Hubbell Family has compiled a detailed account of our American history in five (soon to be six) publications, but our English history is sketchy at best. The Society's trip to England in September, of this year, brought to light more detailed information from the Rock and Ribbesford Parish records and new information about Richard the Immigrant's family history and new information about other Hubbold/Hubballs living in and near Worcestershire county.

This issue will review what has been presented in past publications. Some of this information has been discredited while some still remains speculative. Then a short history of record keeping in England during the 1500 to 1700's is presented; followed by a detailed examination of the parish records and other documents obtained during our trip to England. I hope this review will help separate the Family facts from the myths and help define the direction for new investigations.

The 2014 edition of the Hubbell Family Annual is dedicated to all of our English friends from Worcestershire and Appledore who were instrumental in obtaining, for us, this new information, and who gave their time and opened their homes to us making our visit to England memorable and a once in a lifetime experience.

Biography and History

What We Think We Know About Our English Heritage

Our family came from Worcestershire County, England. This we know. And our surname was, first, Hubbold and then Hubball. This we are pretty sure of. But how far back in time can we trace this English heritage? There has been much speculation over the past 130 years, but the fact remains we know very little for certain. This article will review what we know and what we don't know and will set the stage for the new information that we were able to collect during our visit, last fall, to England.

Hubba the Dane

In the preface of Walter Hubbell's 1881 edition of the "History of the Hubbell Family", Walter does not claim that the early members of the Hubbell Family are lineal descendants of Hubba the Dane, but does state that "the surname Hubbell is of Danish origin". In support of this statement, he cites the 1857 book on the origin of family names, a work by Rev. William Arthur, M.A. who gives the origin of the surname Hubbell as deriving from Hubba the Dane, and the word Hill; or Hubba-hill. (1) This appears to be the first time, in print, of a connection of the Hubbell name with Hubba the Dane. William Arthur cites William Camden's 1587 book as a primary source. (2) However, a review of this work revealed that there was no mention of the Hubbell name in any of its spellings or of Hubba the Dane.

Next, Walter states "All the heraldic ensigns relating to the family in all its branches, offer undeniable proof that it is of Scandinavian blood, and although I cannot prove from history that Hubba, the Dane, left descendants in Wales, where he had his last permanent encampment, there is no doubt that the original inhabitants of "Hubba's-Hill", in Britain, were Danes, and it was there that the name and family originated." (3)(4) Unfortunately, Walter cites only William Arthur's non-existent connection, as discussed above, as support of this statement. Walter's reference to "All the heraldic ensigns relating to the family" is curious. In 1881, Walter was aware of only one heraldic ensign. This would be Henry W. Hubbell's crest that was issued in 1831 (5). At this time I have been unable to obtain any information on the documentation supporting the issuance of this crest and Walter does not discuss it either. Interestingly, the heraldic ensign given to Henry is almost identical to the Hubaud ensign (Hubaud's of Ipsley will be discussed later) but Walter makes no mention of this in 1881.

Building on William Arthur's questionable work, Walter states: "Many family names have been derived from Hubba's-Hill or Hubbill, among which may be mentioned Hubbald, Hubbald, Hubband and Huband, names which have been supposed to have had their derivation from the Christian name Hugh and the Anglo-Saxon word "bald, signifying bold, hence "Hugo the bald" or "Hugo the bold" thus Hubbald, Hubbald, Hubband and Hubband etc. (6)

Walter built his Hubba-Hubball connections with a complete lack of evidence but, never-the-less, he continued to expand his narrative. Walter speculated that Hubba the Dane came from the Tigro-Euphrates valley, in present day Iraq, based on archeological digs performed in the mid 19th century. It seems Walter based this connection solely on the mounds there being called Tell Abu Hubba by the local Arabs. (7) He commented that the archeologist, a Mr. Hormuzd Rassam, uncovered many tablets from this dig which were brought to the British Museum. A recent Internet search of the British Museum's holdings uncovered a number of artifacts from the digs of the archeologist Mr. Hormuzd Rassam. However, nothing in the holdings suggest a connection to an individual named Hubba. The site of ancient Sippar is known today as Abu Habbah, not Tell Abu Hubba.

The Myths

Later, in the 1881 edition, Walter presented an alternative genealogy that completely ignored the Hubba the Dane connection.

According to Walter, Mrs. Ellen (Hubbell) Thurber (A&R# 1006) obtained, around 1841, a Hubbell genealogy from an individual who was travelling through America searching for heirs to ancient estates in Great Britain. He had in his possession armorial decorations and genealogical accounts copied, so he claimed, from libraries in London. (8) See "Hubbell Myth #1" for this story. I present this story only because, although Walter Hubbell in his revised 1915 "History of the Hubbell Family" identified this genealogy as a hoax, I recently Con't on next page

Hubbell Myth #1

This, now discredited, version of the genealogy claims that the Dane King Canute gave the Dane Nobleman Harold Hubbell an estate in Northumberland called the fortress Haroldstone. Harold had 3 sons, 2 fell near the battle of Hastings in 1066 during William the Conqueror's invasion of England. After the English forces were defeated, Harold's third son Hugo Hubbell was forced to leave the estate. He finally settled in the county of Rutland in 1113. Later during the war between the Yorks and Lancasters around 1463, their estate was destroyed. One descendant Walter Hubbell, now landless and poor, moved to the Isle of Man where he worked on ships until he was able to buy a little merchant store in Plymouth, England. He died in ~1515 and left a son, William. William died in 1576. William left one son Francis Hubbell. In 1615, Francis was lost at sea. He left a widow and 2 sons, Francis and Edward. As the story goes, Richard the Immigrant was probably the son of either Francis or Edward. (9)

stumbled across a website that recounts part of this story as the true genealogy of the Hubbell Family. (10)

It's important to note that, in Walter Hubbell's 1881 "History" there is no mention of the town of Bewdley or Rock or Ribbesford Parishes. The only factual information that Walter knew about Richard the Immigrant mainly came from Elizabeth Hubbell Schenck (A&R# 1378) who was, at that time (1880), Historian of Fairfield, CT. Elizabeth provided Walter with the early Fairfield records for his book. Elizabeth, in 1889, published her own "History of Fairfield County, Connecticut". She states only that "Sergt. Richard Hubbell was born in England about 1627, and came to New England between 1640 & 1645." Elizabeth does not document where this information came from but one can assume that the source was from "new world" documents and not from English records. Both Walter and Elizabeth, in 1881 & 1889, had not discovered the English parish records.

In 1915, Walter published a second edition of "The History of the Hubbell Family". In this edition, he retracted most of his conclusions from the 1881 "History".

He acknowledged the fraudulent nature of the Dane Nobleman Harold Hubbell and Francis Hubbell of Plymouth, England genealogy (Myth #1). He also declared that that the origin of the Hubbell name as defined by William Arthur, as deriving from "Hubba the Dane" and "Hill", was incorrect. Instead, he insisted, the name Hubbell was once Hubbald, a name derived from Hubba. And incredibly, Walter expands the Tell Abu Hubba story of our Middle East origins and speculates that in fact our family ended up in England migrating through Scandinavia and the Middle East from India, original home of the Goths! The topical phrase "irrational exuberance" comes to mind here. Walter could weave a story; who needs facts.

After recanting most of his 1881 English genealogy, Walter, in 1915, proposed, instead, that the Hubbell family was descended from Hugo Hubald of Ipsley.

This genealogy was proposed, to Walter in 1914, by Dr. Stephen Johnson Hubbell of Fort Lupton, Colorado (A&R# 4569) and is presented in **Hubbald Myth #2.** The origin of the Danish part of this story is said to have come from a Colorado neighbor of Dr. Hubbell's, an elderly Danish lady who had lived on Peter Hubball or Hubbald's farm in Odense, at Skovby. Not unexpectedly, Walter provided no documentation to support the Harald Hubbald information or the link between Harald and Hugo Hubald of Ipsley.

After "connecting" Harald to Hugo, Walter then claimed that Hugo Hubald of Ipsley was the ancestor of Richard Hubball the Immigrant." (11)

Hubbald Myth #2

Dr. Stephen Hubbell claimed that "Hubba the Dane", who was the son of King Ragnar Lodbrog, left a descendant, Harald Hubbald, in Denmark, living in the province of Odense, at Skovby, his hereditary estate. Harald Hubbald, a warrior, came to England with King Canute in 1016. King Canute gave Harald all of York, Durham and North Umbria as his personal estates. And that this Harald Hubbald was the Danish ancestor of Hugo Hubald of Ipsley, Warwickshire, England.

The Hubald's of Ipsley

The Hubald (also spelled Huboldus, Hubaud) name is well documented. The Domesday Book of William the Conqueror, made in 1086, records the name of Hugo Hubald as holding land at Ipsley, Warwickshire, England, which he held before the Norman invasion (1066 A.D.) This same land was in the possession of his descendants, at Ipsley, in a direct male line of succession until 1730, when the direct male line ended. (12) Ipsley is about 25 miles east of the town of Bewdley and Rock and Ribbesford Parishes.

Although the genealogy of the Hubald Family of Ipsley is well documented, Walter's claim that Hugo Hubald was the founder of the Hubball Family in England and the Hubbell Family in America is not supported by any documentation. Specifically, Walter states that "Richard Hubball, the immigrant from whom the American Hubbell Family has come, was a lineal descendant of Sir Richard Hubald, through a younger son, the title going to an elder brother." (13) Sir Richard Hubald lived around the middle to late 1400s. (14) He was granted a coat of arms in 1497. (15) There is no documentation that the Rock and Ribbesford Parish Hubbold/Hubball line came from a "second son" of Sir Richard Hubald.

Walter does make two interesting comments in his second edition. He states that Richard Hubball, the father of Richard Hubball the Immigrant, was a Husbandman (farmer) of Rib(b)sford Parish, and lived near the town of Redditch. (16) The town of Redditch is not in Ribbesford Parish but instead about 20 miles to the East (a long distance in those days) and about three miles from Ipsley. The existence and accuracy of this document needs to be verified.

He also states that Richard Hubball the Immigrant, was born in Rib(b)sford Parish in 1626 or earlier. This statement implies that Walter was aware of the Ribbesford Parish records and was citing the baptism of Richard, son of Peter and Joane. (17)

1980:

The last twist to the story of our English genealogy was presented in the 1980 edition of the "History and Genealogy of the Hubbell Family" by Harold B.

Hubbell and Donald S. Hubbell. It should be noted that Harold and Donald introduced us to the Rock and Ribbesford Parish records. Besides Francis Wakeman's Will, these records, at the time, were the only factual information we had that supported our English genealogy.

They also introduced a new variant of the Huband genealogy. They wrote: "A modern authority on English surnames, the late P. H. Reaney author of "Dictionary of British Surnames" (1958), traces our name Hubball from Hugh/Hugo/Hubald in the Doomsday Book through Hubaud, Huband, etc to Hubball in 1640. Reaney stated that the name derived from "old German" Hugibald meaning mine-bold. The old French form is Hubaut. To add support to this version of the genealogy, Harold and Donald also cite another modern source; C. M. Matthew who wrote the book "English Surnames". This work does not contain our name but in response to Harold's inquiry the author wrote in 1969 that "it derives from the personal name Hubald which occurs in the Doomsday Book. It is in origin a Frankish name the first part being the same as the popular Hugh meaning 'mind' and the second 'bold'. It was the type of name that the Normans favored when they first came to England but this particular one went very early out of fashion." "You can therefore be fairly sure that your surname became fixed and permanent at a very early date. I would guess that your ancestor was a Norman." (18) In conclusion, Harold and Donald state that it appears "quite clear that we share a common ancestor with the Huband family of Ipsley from whom we descended until a point at which our branch became established elsewhere but probably in Worcestershire."

The Parish Records

This issue of the Annual will present new information about the Rock and Ribbesford Parish records of Worcestershire, England along with other supporting historical documents. Originally, a few select entries from the parish records were published in the 1980 edition of "The History and Genealogy of the Hubbell Family". But it was not until the records were digitized, that a comprehensive study could be undertaken.

To understand the evolution (and accuracy) of these records, over approximately 200 years, will require a review of English political history because the political struggles from 1500 to 1700 directly affected the records. It is probably necessary to remind the reader that at the start of the 1500's, England's civil and political structure was very unstable. Wars for control of the country were frequent and little was done for the average citizen. For the common man in England, the dominant, "stable", political and social structure was the Catholic Church.

After the Norman Invasion of 1066, William the Conquer commissioned a survey of all of England to determine who controlled land and what it was worth, for tax purposes. This record is called the "Doomsday Book". After this, records were kept, by the King, on the landowners (the "ruling class"). The records detailed the taxes or services, owed to the King, by the landowners. These taxes or services were payment, to the King, for the privilege of controlling large amounts of land. But, at this time, neither the State nor the Church kept records on the average individual.

From 1485 to 1509, the first Tudor King, Henry VII ruled England. Then in 1509, his son, Henry VIII succeeded his father to the throne. Henry VIII is remembered as the monarch that split England away from the Pope and the Roman Catholic Church and established the Anglican Church of England in 1534. Before 1534, England's official religion was Roman Catholicism and the Pope was a dominate influence in the affairs of every European country, including England. Henry VIII and the Pope clashed over church doctrine and politics, finally resulting in the split.

In 1534, Parliament passed the "Act of Supremacy", declaring Henry VIII as "the only supreme head on earth of the Church in England" in place of the Pope. Any act of allegiance to the Pope was considered treasonous because the papacy claimed both spiritual and political power over its followers. Henry then proceeded to demolish the infrastructure of the Catholic Church. He destroyed abbeys and monasteries, confiscated church lands and gave them to friends and made life miserable for faithful Catholics, including executing a few (1). But the "new" Church of England was just like the Catholic Church except without the Roman Pope. Henry was, at heart, a conservative catholic.

After the passage of the "Act of Supremacy", Thomas Chromwell, Henry VIII's Vicar General, ordered, in 1538, that each parish priest must keep a book, and that the Parson, in the presence of the church wardens, must enter all the baptisms, marriages and burials of the previous week. The book was to be kept in a "sure coffer" with two locks (one key for the vicar, the other for the wardens). A fine of 3s 4d was to be levied for failure to comply. Many parishes ignored this order, believing it to be the forerunner of some new tax. The order was repeated in 1547 with the stipulation that the fine was to go to the relief of the poor. There is no evidence that any parish records were kept before this date.

The earliest baptism, burial and marriage records for Rock Parish, that survive today, is dated 1546. The first "Hubbold/Hubball" record is dated 1549. (2) The earliest Ribbesford Parish record, that survive today, is dated 1574 with the first "Hubbold/Hubball" entry dated 1600. Earlier records from 1538, for both parishes, if kept, did not survive.

When Henry VIII died, in 1547, he was quickly succeeded by his only son Edward VI, reigning from 1547 to 1553; then Lady Jane Grey, who reigned for nine days, followed by Henry VIII's daughter, Mary, a catholic, who reigned from 1553 to 1558. These were turbulent years for the country and the church.

Everything changed, for the worse, in 1547 when Henry VIII died. His son, Edward VI, ruled under the guidance of a protector because he was only nine years old; but he continued to support the growing Protestant religious philosophy. The Protestant Reformation was set in motion around 1517 in Europe, influencing many dissident Catholics who felt that the Church under the Pope had strayed too far from its roots. Protestants wanted a more personal and simple church. Under Edward VI, "The new English Church did away with the chantries (3) with their priests and their masses for the souls of the dead; relics were discarded, alters, statues, gold plate, the 7 services and high masses-all were gone in 5 years". Now there were 2 plain services a day and a communion once a month; and all services were performed in English not Latin.

In 1553, Edward VI died resulting in much political maneuvering; but in the end the very Catholic Mary (daughter of Henry VIII) took the throne promising religious tolerance. Once in control, she attempted to reestablish Roman Catholic control under the Pope. In 1554 she married the Catholic King of Spain, and parliament submitted to King Phillip as the Pope's man in England. Immediately loyal catholic priests were placed in all parishes and protestant heretics were rooted out and burned. They even dug up dead "heretics" and burned them. Thus began the reign of "Bloody Mary". Then, in 1558, just 5 years after ascending the throne, Mary died and Henry VIII's other daughter, Elizabeth (Elizabeth I) ascended the throne.

Elizabeth I, reigning from 1558 to 1603, restored peace to the Nation. She booted the Pope out and reinstituted the English Church with her as the supreme

governor. Attendance at church was mandatory, fines were levied against those who did not attend and office holders had to swear the Oath of Supremacy. But it was a moderate Protestantism and tolerance was encouraged. Strict Catholics and Puritans objected but the majority of people were satisfied.

However, the Pope and, the now deceased Mary's husband, King Phillip of Spain began an intrigue to reestablish the Roman Catholic Church in England. The Pope sent assigns to kill Elizabeth I and King Phillip was arming for an invasion. Finally, in 1587, the leader of the internal catholic rebellion, Mary Queen of Scots, was executed and, in 1588, King Phillip's Spanish Naval Armada was destroyed along the English coast thus ending the catholic plot.

Beginning in 1598, church records were to be kept in 'great books of parchment' and copies or 'Bishop's Transcripts' of new entries were to be sent each month to the diocesan centre. Previous records were often on scraps of paper. They had to be copied into the new books, but many had deteriorated and were unreadable. The cost of the new books were to be met by charging for entries; this was opposed by many parishes and the act was not enforced until 1603. The cost of maintaining the record books was to be the responsibility of the Parish, and the books were to be kept in a chest with three locks. The week's entries were to be read out each Sunday after evensong.

The Rock Parish records from 1549 to 1641 appear to be mostly complete. See Graph A, on the following page, for a visual representation of the parish data. There are just a few entries for the years 1547 and 1548 and there are no baptism records for 1620. The analysis stopped at 1680 but the digitized records continue to 1850. The Ribbesford Parish records start twenty five years later, in 1574, and are complete except for burial records for the years 1663, 1679 to 1692 and 1694. The analysis stopped at 1700 but the digitized records continue to 1850.

The income from these assets maintained the chantry priest.

Table 1 contains a list of a select group of entries from the Rock and Ribbesford Parish Records and the 1980 "Genealogy of the Hubbell Family". There are discrepancies between the information presented in the 1980 edition of "The History..." and the digitized records provided to us by Edward Inett. The sixth column, "Additional Info" lists the differences. EI refers to the digitized parish records. The discrepancies will have to be rechecked in the original document.

Richards Data:

Table 1 is a list of all readable entries in the Rock and Ribbesford Parish records that identifies a "Richard" as self, a father or a husband. This data has been plotted in the flow chart (The Sons and Daughters of Richard Hubbold) on page 26


Peter and Henry (Harry) Data:

Also included in Table 1 is the Peter and Joane entry that identified a son, Richard, baptized Jan 22, 1625. Some have speculated that this may be the missing record for Richard the Immigrant. Also included are all of the records for Henry and Harry Hubbold. I have included both names because some of the records appear to confuse Henry with Harry. None of these records appear to identify the Henry Hubball and wife Elizabeth from Astley. (See Document #3 for a copy of Henry's Will)

Map of Rock and Ribbesford Parishes: Worcestershire county, England Circa ~1832

The 1832 Ordinance survey map on the facing page is one of the earliest, detailed, maps of the Rock/Ribbesford area of Worcestershire county, England.


The idea for mapping all of England on a one inch to one mile scale was conceived in 1782 but not initiated until 1791. These detailed maps contain local landmarks not found on earlier maps of England or Worcestershire.

The Ordinance Survey donated these maps to the British Museum in 1956. Most have been digitized and are available for viewing on-line. Copies may be downloaded for non-commercial use. 
Areas marked on the map:

- 1) Rock Parish Church (arrow): Where the earliest Hubbold's worshipped and where Richard the Immigrant's grandfather and father worshipped before he was born. The current story that Richard the Immigrant was baptized here is probably incorrect. After Richard's father married Sarah Wakeman, the family started attending the Ribbesford Parish. All of their children were baptized at Ribbesford so its logical to assume that Richard the Immigrant was also.
- 2) Ribbesford Parish Church (arrow): The Wakeman church and likely where Richard the Immigrant was baptized.
- 3) Lane End Farm (circle): In the 1600's this farm was called Parlours (or Parlors) and is thought to be the place where Richard the Immigrant was born. According to Edward Inett, the current owner of Lane End Farm, a Mr. Leigh Jackson, assured him that the deeds to Lane End Farm clearly state that the farm was formerly known as Parlours Farm. Edward, son of Richard (#4) was baptized in 1609 when his father was recorded as living at Parlours. (Parish records) A Hubball was paying rent on a farm near Heightington in 1638 (Document #2), presumably the Parlours farm. This Hubbell is most likely Richard (#5), Richard the Immigrant's father. The farmhouse is on the Heightington Road (just inside the circle at the 6 o'clock position) and extends to Gladder Brook.
- 4) Lye Head(d) (circle): Home to other Hubbolds
- 5) Astley (circle): Home of Henry and Elizabeth Hubball, the weaver

Not shown on this map: Wyre Forest, also called "The Woods" is located just off the top of the map. Bewdley is located in the top right corner, just off the map (just above Ribbesford).



The Sons and Daughters of Richard Hubbold



The information presented in the chart above is an interpretation of a select set of data taken from the Rock and Ribbesford Parish records and the 1980 edition of the "History and Genealogy of the Hubbell Family" by Harold and Donald Hubbell. The complete parish records from both Rock and Ribbesford have been organized by date and by family and has been published on our webpage at: www.hubbell.org/publications/England/

Except for the first column, in the chart, all of the names listed here are identified, in the parish records, as being a son or daughter or married to a Richard Hubbold/Hubbuolde/Hubball. Each unique Richard is assigned a number. Liberties have been taken to match birth, marriage and burial dates. Most of the parish records are incomplete making family connections difficult. For example the record may

state that Richard, son of Richard was born February 23, 1567 at Rock. But without the mother or wife's name it is difficult to place this birth within a family unit. In this example, the placement is easy as there is only one Richard (Richard #2) that predates Richard's (#4) birth. Of course, this assumes that the parish records are accurate and complete (in fact there are gaps in the records making any assumptions risky). I have proceeded, with these connections, where the information makes sense

The dashed lines indicate assumptions have been made (ie there is no written record that Richard (#4) is the son of Richard (#2) and wife Jone). Solid lines denote the existence of evidence to support the connection. Additionally, the re-marriage of Richard (#5) is an assumption. In this example, there is no evidence that the Richard (#5), marrying Alice Mannsell, is the Richard (#5) who married Sarah Wakeman. Some have suggested this scenario, so it has been included. However, this logic does make sense as there are no unaccounted for Richards in the parish records.

It should also be mentioned that the listing of Peter and Joane Hubball giving birth to a Richard (#8), in Jan 1625/26, has been included. It is suggested by some that this is the baptism record of Richard the Immigrant and that this entry is a transcription error and should read Richard not Peter as the father. In the original entry, there is a smudge on the name making it indistinct. (1) It should be noted that the name Joane is clearly visible. However, unexplained by this theory is the incorrect listing of Joane as the mother instead of Sarah. Of course Joane may be a transcription error also. In the parish records, there is no listing (other than this one entry) of a marriage, births or baptisms between a Peter and Joane. What we do know is based on Francis Wakeman's will dated August 1626. In his will, Francis Wakeman, Sarah Hubball's father, left money to both Richard (#5) and Richard the Immigrant (#8); identifying them as husband of Sarah and son of Sarah respectively. Thus, this record suggests that Richard the Immigrant's baptism was in 1626 or earlier.

One of the problems with the interpretations of the parish records is the inconsistencies between readers. There are considerable differences between the data published in the 1980 "History of the Hubbell Family" and the digitized data that were provided to us by Edward Inett. In most cases, when the information differs, I have favored Harold's data. My rational is that Harold closely scrutinized the records looking for "Hubbolds/Hubballs" while the digitized records are a transcription of all of the names, with less time, probably, spent deciphering faded and hard to read names. There are exceptions. There is a Lewis (Leawes) baptized September 1605 at Rock. Later, a Lewis Hubball's burial record (1629) lists his parents as Richard and Sarah in the 1980 genealogy. The digitized records do not mention Sarah. If this is the same individual, Lewis could not be the son of Richard and Sarah as they were not married until 1621.

Many other inconsistencies exist. See the family tables on the website for a complete listing of these discrepancies.

(1) This data has been recently rechecked by Mary Ann Hubbell of Utah. She informs us that the Rock Parish records are available, on microfilm, at the genealogy library in Salt Lake City, UT



Parish Record Dating

When reviewing the dates from the parish records it is important to keep the following facts in mind.

For any date prior to 1752, the first month of the new year was March, not January. For example before 1752, a date of Feb 20, 1602 would be written Feb 20, 1603 using today's calendar. Before 1752, the new year began March 25 not January 1. Some of the transcribed records have been converted to the new calendar while others have not.

The Julian calendar was used throughout Europe in the middle ages. This calendar was inaccurate, resulting in about 3 days inaccuracy every 400 years. In 1582, the Pope declared a new calendar, called the Gregorian Calendar. Catholic European countries adopted the new calendar but England resisted. Mostly because it was sponsored by the Pope; and England was at "war" with Catholics, in general, and with the Pope specifically. It was not until 1751, that Parliament passed a law changing the calendar. However, leading to more confusion, different parts of England adopted the new calendar at different times after 1700. For a more detailed discussion see Harold and Donald's 1980 "History and Genealogy of the Hubbell Family" (p.14)

Other Records

The digitization of public records is progressing. Last fall, The Hive, the repository of public records for Worcestershire County, England reported that, to date, they have digitized less than 10% of their holdings. No doubt, there are some records that may never be digitized, but as the percentage increases, the easier it will be for us, on this side of the pond, to access the data. This digitization process has already resulted in some recent discoveries.

Quite by accident, I stumbled upon the website for the National Archives in London . (1) The Archives contained some Hubbold information about the Will of Robert Hubbold, Yeoman of Claverley, Shropshire, (2) dated 1672. Other Hubbold's were listed. Margie Hlava was able to obtain the digitized Claverley parish records. The first two Hubbolde entries, a burial and a baptism is dated 1569, for the family of John Hubbolde. This is just 20 years after the first recorded Hubbold entry in Rock Parish (1549). This certainly leads to some interesting questions. Is the Claverley Hubbolde clan related to the Rock Hubbold clan? Which area was settled first or did they arise independently from each other? And of course, besides Claverley, we now suspect that there might be a Hubbold clan in Astley. These leads could shed new light on the family's origins in England.

- (2) Claverley is located in the next county (Shropshire) just north of Worcestershire, very close to the Severn River. As the "crow flies" from Rock it is about 20 miles. Other entries on the site were for the Will of William Hubbold, Yeoman of Claverley, Shropshire 1657 and the Will of John Hubbould, Merchant Tailor of Saint Mary Le Savoy, Middlesex 1666.

A Few Early Claverley Parish Records

Claverley is a large parish of 8,185 acres, six miles east of Bridgnorth, in the Hundred of Brimstree and the Diocese of Hereford. It comprises the hamlets of Aston, Beobridge, Broughton, Dalicott, Farmcote, Gatacre, Heathton, Hopstone, Ludstone, Shipley, Sutton, and Woundale. The first 15 Hubbold parish records are:



Along with the digitized parish records, four other document were made available to us. These documents are presented next and help shed new light on the Hubbold/Hubball Family of Worcestershire. Document #1, likely, concerns Richard (#4), Richard the Immigrant's grandfather. Document #2 places a Hubball (most likely Richard (#5) (Richard the Immigrant's father) near Heightington. Document #3 introduces us to a previously unknown Hubball Family living in Astley in 1607 and Document #4 likely refers to a son or grandson of the Henry living at Astley. Until the parish records at Astley can be studied, the Henrie Hubballs of these two documents will remain obscure.

Document #1: A Testimonial on Behalf of John Lerego The Elder, Innkeeper at Mopson's Cross 1609. Mopson Cross is located on the main road just above Lye Head.

Comments on Document #1: Such testimonials as this were necessary because innkeepers had to be licensed by the Justices; usually local landowners. They needed to be honest and upstanding citizens of their community, especially on a major east-west road connecting Bewdley and points east with the country to the west. This document is signed by George Benson, Rector of Rock Church,

the two church wardens (Richard Hubball being one of them) the schoolmaster and twelve parishioners. The Richard that was a church warden was either Richard (#3) or Richard (#4). The evidence suggests that it was Richard (#4) (Richard the Immigrants grandfather). Consider the following rational. Sarah Wakeman was the daughter of a prosperous Bewdley merchant. Her family was well respected and connected in the area. She would probably not have considered marriage to someone with no position or stature in the community. Richard Hubbold (#5), the son of Richard (#4), a church warden, and a man of some stature in the parish could have bestowed enough status onto the Hubbold family to make Richard (#5) a suitable prospect. Document #2

Highteton Rent Roll 1638: The partial document, below, indicates that a Hubball (possibly Richard (#5)) was paying rent on land near Highteton (now spelled Heightington) in 1638. It is thought, at this time, that Richard the Immigrant's grandfather, Richard (#4), was living at Parlours (now called Lane End Farm) in 1609. This fact is recorded in the Rock baptism records as: Edward, son of Richard of Parlours, born 11/1609, father. (Refer to the flow diagram on page 26). Parlours is approximately 0.5 miles up the Heightington road from the town of Heightington. This assumes that Edward was the son of Richard (#4) and not Richard (#3). 

When Queen Elizabeth I died in 1603, James I assumed the throne and ruled until 1625. The country remained at peace during this time. Then in 1625, James I died and his son Charles I became King. King Charles I was determined to rule England without the assistance of Parliament. He introduced many

controversial measures and his support for "high-church" religious practices (read-Catholicism) aroused considerable alarm among the more zealous protestants, or "puritans". They came to fear that Charles was pursuing a hidden agenda: that he planned to remove his people's rights, or "liberties", and to restore England to the Catholic Church. Then, in 1637, Charles attempted to introduce a new form of prayer book. This started a series of confrontations with parliament that eventually led to civil war.

It was during this time (sometime around 1638-1640) that Richard the Immigrant, about the age of 12 or 13, and the Wakeman Family left England for America. Starting in 1642 and lasting almost ten years, England was torn apart by a bloody civil war. On the one hand stood the supporters of King Charles I: the Royalists. On the other stood the supporters of the rights and privileges of Parliament: the Parliamentarians. The English Civil War came to a climax when King Charles I's army was routed and he was executed in January 1649. But the fighting continued between the Parliamentarians and the slain King's son, Charles II.

England entered a period known as the English Commonwealth, and the country was a de facto republic, led by Oliver Cromwell. Cromwell finally defeated King Charles I's son, Charles II, at the Battle of Worcester in September 1651 (Worcester is about 14 miles, "as the crow fly's" south of Rock), and Charles II fled to mainland Europe. Charles II chose to confront the parliamentarian army in the Severn Valley, at the town of Worcester, where his father had found the most constant and the most numerous supporters in the first war of 1648.

After Charles II defeat, Cromwell became virtual dictator of England, Scotland and Ireland, and Charles II spent the next nine years in exile.

The political crisis that followed the death of Cromwell in 1658 resulted in the restoration of the monarchy, and Charles II was invited to return to Britain. On 29 May 1660, he was received in London to public acclaim. In 1662 King Charles II married a devout catholic, Catherine, in a public Anglican ceremony and privately in a Catholic ceremony.

In response, the English parliament, from 1661 to 1665, enacted laws known as the Clarendon Code which re-affirmed the supremacy of the Anglican Church and ended tolerance for dissenting religions. Charles acquiesced to the new laws even though he favoured a policy of religious tolerance.

One of the laws enacted was the Act of Uniformity of 1662. This law was designed to cripple the power of the Nonconformists, or Dissenters. It was an attempt to codify the practices of the reformed Church of England. It dictated the form of public prayers, administration of sacraments, and other rites of the established Church of England. Adherence to this act was required in order to

Document #4: Displacement of Burgesses 1662

This document records that Henrie Hubball was identified as one of a number of individuals who refused to take an oath of allegiance to Parliament and thus was excluded from holding any office in the church or the government.

hold any office in government or the church. As an immediate result of this Act, over 2,000 clergymen refused to take the oath and were expelled from the Church of England in what became known as the Great Ejection of 1662. This act created the concept of non-conformity, with a substantial section of English society excluded from public affairs for a century and a half.

Document #4 records the "ejection" of those men who, in 1662, refused to take the oath of loyalty. Bewdley had been given the right to send one representative to Parliament in its 1606 Charter. **Henrie Hubball** must have been a leading citizen of the town to be considered as a candidate for this office. This **Henrie** is not recorded in the Rock or Ribbesford parish records. Document and translation courtesy of Edward Inett.

BUSINESS WITH ACTION ITEMS: a motion was passed setting up two endowment funds with the Greater Des Moines Community Foundation; one Fund without restrictions, and the other as a restricted Endow Iowa Fund which benefits Iowa residents. Craig Hubble passed away October 4, 2014 at age 87 from congestive heart failure. Craig was a 22 year THFHS member (1992 - current).
