## SHOT IN THE BACK.

Serious Result of a Quarrel Between Two Youngsters.

Somerser, Ky., Aug. 17.—Roscoe Hubble and Caldwell Hunt, living at Rock Lick, in the eastern part of this county, became involved in a trivial quarrel while attending a singing school at that place last night. Hunt was drinking to excess, and went up to Hubble and asked him if he kept any brandy peaches at his store. Hubble told him he did.

Hunt then went on over to the store and purchased the peaches, and, returning, met young Hubble, and said: "Hubble, what did you tell me that d-d lie for!" Hubble made some reply which did not exactly suit Hunt, and he proceeded to demolish him with a stone. He knocked Hubble down, and then started to run. Hubble jumped to his feet and fired at the retreating figure, the ball striking him in the lower part of the back, inflicting a fatal wound. Hubble boarded a north bound train at this place in the morning, and escaped to parts unknown. Both are young men, about eighteen years old. Hunt's recovery is hardly possible.
