The Committee appointed by your Honors to receive, sort, and count the Votes to this Assembly for Gentlemen to stand in nomination for Election as Representatives of the People of this State in the Congress of the United States—beg leave to report, That on the Eighth day of the present Session, they received, sorted, and publicly counted such Votes A D 1771 the Covenant of Matrimony was entered into by, and between her and Samuel Cunningham of said Middletown, and that from the day of her said marriage untill the Time of preferring her said Petition she has ever conducted towards the said Samuel in a manner becoming the Character of a Wife, but that the said Samuel has for a number of Years been addicted to an intemperate Use of Spiritous Liquors, whereby he has become very passionate, and treated the petitioner with great Cruelty by frequently assaulting, beating, and bruseing her, and even threatening her Life, and also made sundry attempts to be criminally conversant with other Women, from which she has reason to believe that he has been unfaithfull to her bed, praying to be released from her matrimonial connection with the said Samuel, and that all the property brought to the said Samuel by the Petitioner by vertue of said marriage, and now in his possession be restored to her as per Petition on file, which facts are fully proved.

Resolved by this Assembly that the said Hannah be, and she hereby is divorsed from the said Samuel, and wholly released from said Marriage Contract, and in respect of of [sic] all the property real or personal brought to the said Samuel by Vertue of said Marriage by the Petitioner and now in the possession of the said Samuel, that she have the sole, and

exclusive Right to, and disposal of the same.
