 Whereof I do hereby acknowledge & my self therewith Content & paid Do him Grant  
 Bargain Sell & Confirm unto him <sup>the</sup> Josiah Curtis Jun<sup>r</sup> & to his Heirs & Assigns for ever nine acres  
 Right of Commonage within a Town of Stratford within one mile of Stratford Old Town  
 meeting House Hence together with its own Mills vizt. by Stratford Proprietors granted  
 to be laid out on the Right of Commonage within four miles of the meeting house or  
 him if so Josiah Curtis his Heirs & Assigns for ever to have & to hold if above  
 granted & bargain & promise with a cesser tenance thereof unto him if so Josiah  
 Curtis & his Heirs & Assigns for ever to his & their own proper use & behoof &  
 also if so David Hubbel hereby do for my self & my Heirs & adm<sup>n</sup> Covenant  
 with if so Josiah Curtis & his Heirs & Assigns if at & until if any of these pre-  
 sent I am well satisfied of if promises for a good indefeasible estate in fee simple  
 & have good Right to Bargain Sell if same in manner & form as is above  
 written And if I am if none of all Incumbrances whatsoever And furthermore  
 I do David Hubbel do by these presents give my self & my Heirs for ever to War  
 & Assigns against all Claims & Demand whatsoever In Witness whereof I have  
 hereunto set my hand & Seal of my own hand & Seal of my own hand & Seal of my  
 our Sovereign Lord George the 2<sup>d</sup> of Great Britain the 14<sup>th</sup> Year of his Majesty's
