PREFACE

As indicated by the dedication, this volume is indebted to the manuscript collections made by Mr. Winthrop H. Perry and Mr. Orrando P. Dexter much more largely than to any other private source. The task of the present compiler and editor has not been limited, however, to the classification and arrangement of the voluminous data copied and abstracted by them with infinite care from original sources.

Members of the Eunice Dennie Burr Chapter donated their time to visit many persons who possess old family Bibles and to copy the records contained therein. These have been incorporated in this volume, except when too recent in date; and the copies were then deposited at the State Library in Hartford, where they may be consulted by any who are interested.

Extensive data were also obtained from the manuscript diary of Peter Perry, which contains a mortuary list covering many years, through the kindness of Miss Loretta Brundige Perry of Fairfield; and from the large manuscript collections of Mr. Cyrus S. Bradley of Fairfield, to whose generosity our volume is considerably indebted.

We make a general acknowledgment to the many who have been helpful in supplying private records or the results of their personal research, regretting that the limitations of space forbid individual mention of each one. Special mention must be made of aid received from Mrs. Helen Turney Sharps of Fairfield, Conn., on several families, and from Mrs. Cornelia Penfield Lathrop of Bridgeport, Conn., on the Penfield and other families, as well as from the latter's fascinating and helpful book, *Black Rock* (1930). To Mrs. Nellie L. Elwood of Westport, Conn., and to Mr. Frederick Wood of Springfield, Penn., we are indebted for data on several families; to Mr. Clarence A. Torrey of Dorchester, Mass., for important additions to the Adams family; to Mrs. G. E. Fellows of Salt Lake City, Utah, for help on the Sherwood family; to Mrs. Thomas D. Watkins of Utica, N. Y., for Osborn data; and to Mrs. C. W. Nichols of New Britain, Conn., and Mrs. Walter Corbin of Florence, Mass., for Squire data.

Among printed histories utilized by the compiler, special mention should be made of those of Stratford (Orcutt) and Fairfield (Schenck); Trinity Church, Southport (Guilbert); the Commemorative Biographical Record of Fairfield County; Yale Biographies (Dexter); and also the Old Burying Ground of Fairfield (Perry). Many printed genealogies have been consulted, notably those of the Buckingham, Burr, Chapman, Hendrick, Higgins, Hubbell, Jessup, Middlebrook, Redfield, Sanford, Solley, Spalding, Sterling, Stratton, Trubee, Wakeman, Ward, and Whitney families; and the excellent typed Seeley genealogy. The printed Colonial and State records (eighteen volumes) were searched page by page for the appearance of Fairfield names.

Since prefaces are so seldom read, and the present volume should speak for itself, the compiler need say but little of his own labors. So far as possible, original record sources have been consulted. In addition to the copies of church records and gravestone inscriptions and the abstracts of probate and land records, contained in the collections of Mr. Dexter and Mr. Perry, the

compiler has carried the search of the probate records in Fairfield to 1832, and has covered the records of the Danbury Probate District (chiefly for Redding families) from 1744 to 1830; besides gleaned much information from the land records of Stratford and Norwalk concerning intermarriages between the people of those towns and the people of Fairfield. Much has been obtained from other sources, such as the pension abstracts, the County Court records at Bridgeport, and the Connecticut Archives at Hartford.

A work so extensive as this, even though liberally financed, cannot hope to be perfect, either in completeness or in accuracy. The aim of the compiler has been to show what the records contain, and for this purpose we have usually indicated the source of vital entries, and have included very brief abstracts of wills and distributions. It is believed that errors in copying, clerical errors, and mistakes in judgment, will be rare; but they cannot entirely be avoided unless a lifetime be spent on such a compilation as this. It is estimated that upward of 50,000 vital entries of all kinds have been classified and entered, not to mention several thousand abstracts of probate and land records. The work has been compressed into the course of two years, and during the same period Volume III also was edited, prepared for publication, and indexed. The compiler would have preferred to labor another year on the present volume; but the subscribers to the first volume have become impatient for the sequel, and the funds generously provided for the compilation are nearing exhaustion. With regret, and without further apology for such imperfections as may be found in the volume, the compiler lays down his pen, confident that he has accomplished the best that could be achieved within the necessary limits of time, cost, and labor.

EXPLANATORY NOTES

In order to aid the genealogical inquirer in tracing family lines from the present volume back through the generations recorded in Volume I, brief synopses of the early generations are given herein at the head of each family in small type; and heads of families have been assigned reference numbers.

Towns mentioned are in Connecticut unless otherwise specified or unless, like New York City, the place is too well known to require more definite identification.

PARISHES CONNECTED WITH TOWN OF FAIRFIELD

[This list was compiled by Miss Loretta B. Perry, to whom also we owe the suggestion of the map for a frontispiece, and was rearranged somewhat by the Editor. Readers are referred to the map for further information.]

(A) CONGREGATIONAL

I. FAIRFIELD SOCIETY. Church organized 1639. [Records of town and parish included to beyond 1800.]

II. BRIDGEPORT FIRST SOCIETY. Established 1691 as Pequonnock or Poquonock Society in Fairfield and Stratford, by division of the First Societies in those towns. Called Fairfield Village, 1699; name changed 1701 to Stratfield Society. Name formally changed 1847 to Bridgeport First Society. [Records included except for Stratford surnames.]

III. GREENS FARMS SOCIETY. Set off as the West Farms Society in 1711, and came to be called Greens Farms. The part of Fairfield including this Society was incorporated as Westport in 1835. [Records included to beyond 1800.]

IV. GREENFIELD HILL SOCIETY. Set off in 1725 as Northwest Society in Fairfield; name changed to Greenfield, 1727. [Records included to beyond 1800.]

V. REDDING SOCIETY. Established in 1729 as Redding Society in the town of Fairfield. This part of Fairfield was incorporated as the town of Redding, 1767. This region was early known as Lone town and Chestnut Ridge. [Records of town and parish included to beyond 1800.]

VI. WESTON SOCIETY. Established 1757 as Norfield Society in Fairfield and Norwalk by a division of the Societies of Greens Farms, Greenfield, and Wilton. Part of Fairfield (including that part of Norfield) was incorporated, 1787, as the town of Weston. The part of Norwalk which had been in Norfield Society was incorporated, 1802, as the town of Wilton. This parish is sometimes erroneously called Northfield, but the name, Norfield, was formed from syllables of the names Norwalk and Fairfield. [Records of town and parish included to beyond 1800.]

VII. EASTON SOCIETY. Established 1762 as North Fairfield Society in Fairfield and Stratford, by a division of Greenfield, Stratfield and North Stratford Societies. The part of Fairfield which was included in this Society became the town of Weston in 1787. The part of Stratford which was included in North Fairfield was added, part to Trumbull in 1797, the rest to Bridgeport in 1821. The part of Weston which was in this Society was incorporated as the town of Easton, 1845. [Records included to 1800.]

VIII. BLACK ROCK SOCIETY. Set off from Fairfield, 1849.

(B) EPISCOPALIAN

I. TRINITY CHURCH. Organized at Fairfield, 1725; the church was located at Mill Plain until 1842, when it was voted to move to Southport. [Records partially included to beyond 1800.]
