African American Database.

The ownership of slaves by descendants of Richard Hubball, the immigrant (ME#1) (1), is an important part of our family history. This database documents Hubbell/Hubble slave owners and African Americans with the Hubbell/Hubble surname. The data is organized by state but placing an individual under one state heading does not limit them from appearing in other states. The symbol "+" in front of a name denotes that additional information concerning that individual is listed later. When no "+" appears in front of a name, then no additional information is known about that person. The capital 'AF' followed by a unique number is a reference number for each African American individual. Numbers have been assigned randomly, by state. Other letter/numbers, in parenthesis, following the AF number indicate an older reference number for that individual; numbers that were used in the Additions and Revisions (1995) and Millennium (2017) genealogies and listed in the unclassified section. The terms for race. i.e. black, mulatto or colored are listed as used in census returns and other vital records.

A child born into slavery was given a name selected by the child's family. While this name was kept secret, the child was known by a name given by the slave owner. Once the slaves were freed, they found they needed another name in addition to the given name. Most did not want to use their former owner's surname, (about 20% did use the slave owner's name) so new surnames were created, usually from a local region, (Smithfield), famous people (Washington), the Bible, personality of the person (Hardy), occupation (Smith) or to declare their new freedom (Freeman) (2).




Figure 1: The Distribution and Concentration of Slaves in the Southern States Compiled from the 1860 US Census. Published 1861

In the early years the births, marriages, deaths and ownership of slaves were poorly documented making a comprehensive list impossible. To construct this database, the authors relied on many sources, including tax records, slave schedules, census records and Wills and, later, military records to provide most of the information. For some states, tax records provided a clear picture of the number and duration of slave ownership. Unfortunately, the tax records provided only information on older slaves and no names were included. For tax purposes, slaves were considered property and therefore only slaves over the age of 14 or 16 (depending on the state) were enumerated and taxed.

Slave schedules and census data, compiled every 10 years, provide limited information. Typically, a slave owner was identified, and the gender and approximate age of each slave was recorded. To ascertain the accuracy of the slave schedule information, a comparison of tax data information versus slave schedules or census data have been performed on selected individuals. Unfortunately, in some cases the information from the two sources varies considerably.

The Wills of slave owners provide the most accurate information of slave names, gender and age. Unfortunately, Wills only provide a snapshot of an owner's holdings at the time of his death.

Alabama

Alabama abolished slavery at the end of the Civil War, 12 April 1865. However, during reconstruction, discriminatory laws against blacks were passed by those unhappy with the outcome of the war.

Slaveowners:

ME#785. Loring Curtis Hubbell. son of Wolcott (ME#265) of Lanesborough, MA; b.1796 MA d.1882 NY. Around 1837 Loring and family moved to Mobile, Alabama. He was appointed to the powerful position of Justice of the Peace in Mobile in 1853. See "Florida" for lists of Loring and his wife Amelia's slave holdings. In 1850 the Loring Hubbell slaves were in 3 locations: the first location lists 31 slaves; the second lists 5 and the third lists 1. In 1860 there were also 3 locations: the first had 1 slave, the second enumerated under Amelia had 26 slaves, and a third location had one blind slave under the name of E. C. Hubbell. *The Mobile Register & Journal* reported that Alexander Le Coste, a slave of Mr. Hubble was admitted to the city hospital 2 December 1841. In 1860 the family owned 28 slaves, 10 of which were fugitives (3). Amelia Hubbell died in 1862 and at the end of the Civil War all the slaves were freed. Loring moved to Champlain, New York and remarried.

Connecticut

The first slaves in Connecticut were CT Indians captured during the Pequot War of 1638-39 (4). By the middle of the 1600s enslaved Africans began arriving in Connecticut. By the time of the Revolution (1776), Connecticut had more enslaved Africans than any other New England state (5). However, records of slave ownership in colonial times are scarce with only a few surviving examples. Although it's certain that Hubbell's owned slaves before the Revolution, only a few examples survive. One example of Hubbell slave ownership is a court action dated 9 November 1750 when Ezra Hubbel of Stratford (ME#73) sold a Negro called Cork to Joseph Lewis Jr. Cork died 6 May 1751 and a court case ensued claiming that Cork was not in good health when sold as stipulated in the bill of sale (6). Ezra would later relocate to Kent, Litchfield co.

The first known African using the Hubbell surname was Primas Hubbell of Kent, Litchfield co. Primas was a Revolutionary War soldier in the Connecticut Line of the Continental army serving in January 1780. He was paid for his service in Kent on 3 March 1783, personally appearing before Jedediah Hubbell (most likely ME#143), the Justice of the Peace for Kent (7). In 1784 a Connecticut "Bill of Gradual Abolition" provided that any child born into slavery after 1 March 1784 would be free at age 25. Finally, slavery was officially abolished in Connecticut in 1848.

The first systematic documentation of slave ownership in Connecticut was the 1790 census. The census listed slave owners but not the name of the slaves.

Even as late as 1790, slave ownership in CT was not widespread. In the 1790 census for Fairfield County, there were 9,169 white males over the age of 16 that were head of household and only 795 slaves, or at most, about 9% of the households owned slaves. Two of the seven Hubbell's owning slaves; Zalmon, and Amos were shipping masters living in Bridgeport.

In the 1800 Connecticut census the number of Hubble slave owners dropped from 9 to 6. Besides the census data there survives one entry documenting at least one slave owned by Salmon Hubbell (ME#481). His name was John Armur, born 6 May 1811 (8). See Figure A.




Figure 4: "Salmon Hubbell has a molatto boy named John Armur born as a slave the first Monday of May 1811"

District of Columbia

When the District of Columbia was established in 1801, slavery was legal in the two states from which it was created: Maryland and Virginia. Slavery remained until 16 April 1862 when President Abraham Lincoln abolished slavery in the district.

Florida

Florida has a long history of slavery beginning with Indian tribes under Spanish rule. Slave populations grew under United States rule with the advent of cotton plantations. Slavery in Florida ended formally with the passage of the Thirteenth Amendment.

Joseph's will of 1824 states that he owned 18 male and female slaves in addition to several tracts of land. He mentioned 3 female slaves, Mary, Antonio and Roseta. He granted Roseta freedom because "I was raised by her". He stated that he had no children, and his estate went to his wife Amelia.

After his marriage it appears that Loring managed the estate. On 28 June 1838 he shipped a slave Leandro age 22 on the steamer SWAN to Pensacola. He also used the steamer SWAN to ship Dolores, 22, and her son Francisco, 3, to Pensacola. On 22 December 1838 he shipped Jose age 28, 6 foot 7 inches on the Steamer CHAMPION from Pensacola to Mobile. He shipped Hellen, age 30, on the Steamer CREOLE from New Orleans to Mobile and Laurtetine a female age 12, 4 feet tall arrived at Mobile from Pontchartrain.




Figure 6: The Swan steamer shipping manifest shipping two slaves ca1830s

During the Civil War, Loring Hubbell hired out slaves to the Confederate Government for labor to build military installations. Eight male slaves were sent to the Navy Yard at Pensacola 29 May 1837. Fort Morgan was an important fixture in the defense of Mobile Bay built by slave labor. The following (Figure 7) is a list of known enslaved persons owned and managed by Loring Hubbell (9).

Kentucky

During the 1700s, many adventurers and hunters had explored the Kentucky country, but it was not until 1773 that Janes Harrod, an early Kentucky hunter and surveyor, lead a band of 31 men, including slaves, into the interior of the country and laid the foundation of the first settlements that would later be called Harrodsburg and Danville. Daniel Boone, in 1775, would lead a party of explorers and settlers, including slaves, to north central Kentucky to establish the fort of Boonsboro.

By the 1790 census there were 61,133 whites and 12,430 slaves in the Kentucky territory. Slaves numbered 17% of the population. In contrast 39% of the population of Virginia were enslaved. In June 1792, the Kentucky territory was separated from Virginia and became a state, joining the Union. Like its parent, Kentucky was a slave state and about half of the white population and two-thirds of the slaves came from Virginia.

At the beginning of 1799 a convention was scheduled to meet in Frankfort, KY, in July, for the purpose of forming a new state constitution. Popular meetings were held across the state to discuss the content of the constitution. The mood at that time indicated that a large majority of the people favored the continuance of slavery in the commonwealth. The new constitution, reflecting this sentiment, taking effect on 1 June 1800.

One of the most important provisions, in the new constitution, was the clause concerning slavery. It showed a strong prejudice against the commercial trafficking in slaves and forbade the trafficking of slaves "into the State as merchandise, and none were to be brought into the state that were imported into America after 1789." It further recommended that the legislature pass laws "permitting the emancipation of slaves under the limitation that they shall not become a charge on the county in which they reside." This clause is clear evidence that the citizens of Kentucky recognized that slavery had inherent problems that would have to be dealt with in the future (10).

Early slaveowners in Kentucky usually had only a few slaves to aid in working the family farm. But by the 1830s, as farms, in some regions of the state, became larger and more prosperous, farmers began increasing their slave holdings. This increase produced an excess of slave labor beyond the family needs, allowing for slaves to be sold or bartered. Most of the larger slaveowners lived in the fertile blue-grass region of the state that included Franklin, Scott and Lincoln Counties. Pulaski County, due to its poorer soils, could only support smaller farms employing fewer slaves.




Figure 10: The data from two different sources provide contradictory information about slave ownership. Above is a comparison of slave schedule data versus Pulaski County Tax data for William H. Hubble (ME#1239). One reason for the difference is that only slaves over the age of 14 were counted for purposes of taxing the owner.

In 1856 William H. gave each of his surviving male children (Joel, Edward and Isaac) one slave each and one slave went to his son-in-law, George Gastineau, husband of his daughter Francis Anne. William H. died in 1861. His Will lists 9 slaves who were distributed to his two surviving sons, Isaac and Joel, to his daughter-in-law, Helen James Hubble (widow of Edward) and to his son-in-law George Gastineau husband to Francis. Slaves listed in his Will were:




Figure 11: Genealogy of Virginia, Kentucky and Missouri Slaveowners

Crab Orchard, July 20th, 1907. Another of the worthy blacks of the Crab Orchard population has "gone to that boon from whence no traveler ever returns." "Surrelda Welch, who was an Owsley, belonging in the times of (what is sometimes called the days of servitude) to Hon. John Samuel Owsley. She entered upon the service of my sister, Catherine McAlister, in 1875, at the poor farm of Lincoln County and a more devoted, loyal servant never carried the keys of smoke-house or pantry. Poor Relda had three great, prominent traits: Truth, honesty and virtue. She would enter into no joke if funny fibs had to be told. She was as pure as the Tennyson monument of Baysoft in the solitude of the frozen zone-a monument erected by nature alone, unaided by man. Relda was one of those true, faithful and honest servants that never had to hunt a place. After living with my sister for years and waiting on my dear old mother for years, she then found a most hospitable home at Mr. and Mrs. Robert Collier's and for years she followed the flag of fidelity wherever they went. Brodhead or Crab Orchard, she staid with this excellent family, and never were man and women better pleased with a servant nor servant more devoted to those whom she served. Mr. Collier and I in talking about Relda since death, agreed that for truth, honesty and virtue, she was a monument in ebony. It was true, but no monument of purest Parisian marble ever gleamed more stately and pure! What more could be said of white or black? These are certainly the three great cardinal virtues that shine in the casket of male and female character. Although Relda married a Welch, yet Tom's mother was a Bobbitt, now Nancy Welch. Tom's mother was twice married. In 1858, when brother Jim and I were slaves and our slaves all free and without care, the great wedding ceremony between Nancy Bobbitt and Andrew Hubble took place in the "big house". White folks were there from all around and the colored folks from the McAlisters', Owens' and Evans' were represented. It was the event of the year, and Tom, who afterward went by the name of his step-father, Billy Welch, was the second son born of that union of the house of Bobbitt and Hubble. And Relda marrying into the family and living with us so long always seemed like kinfolks. Whenever one like Relda leaves the earth she is entitled to a notice recounting her virtues, her truth, her honesty and fidelity more extended than I can devote to her here. Relda, you have fought a good fight, finished your course, and when you were seen approaching, no doubt heaven opened wide her eternal gates with harmonious sound on golden hinges turning. "By Fontain Fox Bobbitt.

Followed by another article dated 9 March 1900 Interior Journal (Stanford, KY): Tom Welch and Jim Graves were given a year each, yesterday, for stealing 144 bottles from Curtis Gover's stable. T.J. Culton and Hon. Fontaine F. Bobbitt defended them and the latter among other things, said in his speech: "Now, gentlemen of the jury one of these defendants is of noble blood. His mother was a Bobbitt, his daddy a Hubble, akin to "Horn Took", his step-daddy was a Welch. If that

Negro has any bad blood in him, it comes from his step daddy" [the reference to "Horn Took" refers to Robert Lee (Took) Hubble, ME#2963; a prominent lawyer/politician from Hubble, Kentucky (Lincoln County), son of William (ME#1256)].

There is much confusion concerning the following two individuals and their children. It's possible that there is only one African American Henry Clay Hubble and that this individual married multiple times and had many children. At times he is referred to as Clay, Henry Clay and Henry in the records. From 1869 to 1871, a Henry Clay Hubble served in the Kentucky militia. African Americans were allowed to serve after the passage of the Militia Act of 1862. Mostly they were assigned guard duty at Camp Nelson, KY.

Archibald's move to Kansas, after 1871, is remembered by Lucille Campbell. The following is an excerpt from a story written by Lucille Campbell and published in the Winfield, KS newspaper 18 March 2016. "My great-grandmother came to Kansas by wagon train from Kentucky. They were accompanied by one of their former slaves, Arch Hubbell. He had married a slave from another plantation. He was well thought of by my family. His wife was sold and he never found her. He filed on land in Wilson County but was ill-treated there."

Lucille's great-grandmother was Orpha Black (1854-1941), born in Pulaski co died in Neodesha, KS. She married Martin Lafayette Fulbright. Orpha was the daughter of William Dye Black and Naomi Surber.

The last record we have of Archibald Hubble is from the 1900 census. Archibald is a boarder living in Elsmore Township, Allan co. Kansas.




Figure 14: AF119 Dink Hubble WWII Draft Registration Card




Figure 16: AF144 William Bright Hubble's 1918 draft registration card

Lester retired from the United States Navy as a commissioned officer in 1988 with 26 years of service and joined the San Diego Police department, retiring in 2002. Moving back to his hometown, he was the unsuccessful democratic candidate for the Butler County, OH County Commission in 2008 and 2010. In 2011 Butch purchased from the city an abandoned lot and turned it into a community playground. Calling it "Hubble Park", after his father, Lester, it is located at 131 Hanover Street, across from his childhood home. In 2004 Butch, with other likeminded citizens, founded the Hamilton Community Council and he became its chairman in 2012. Under the Hamilton Community Council, he started the Second Ward Central Avenue Project whose aim was to revitalize the neighborhood along Central Avenue in Hamilton. In 2013 in recognition of his years of community service work he was awarded the Janet Clemmons Community Service Award. That same




Figure 18: AF162 Lester Harold Hubble Jr.

year he became the director of the Booker T. Washington Community Center in Hamilton. Which Ike Hubble?

Ike Hubble is a thief of monumental gall. He stole a pair of pants from Joe S. Jones' store and in a short time took them back to trade for a pair that would fit him. Mr. Jones suspicioned at once that they had been stolen, but the negro put on a bold front and declared he bought them from Wallace Withers two weeks before. As the pantaloons were of unusual size, Mr. Jones remembered to have shown them to a long-legged customer that morning and so informed the negro, who finally admitted that he had stolen them. He also confessed when brought into court and was given 30 days in jail .- Stanford Journal.

Ike Hubble: 10 June 1891

THE two negroes, George Middleton and Ike Hubble, who assaulted Jim Thompson on Tuesday night last, were fined at their third trial yesterday, \$35 each and costs.

Ike Hubble: 16 Aug 1889

As Jim Thompson was walking down Main street Sunday night about 9 o'clock he was accosted by George Middleton and Ike Hubble, both colored men and both pretty well filled with whisky. After using filthy epithets towards Mr. Thompson, one of the men knocked him down and was in the act of beating him over the head while he was down, when friends of Mr. Thompson interferred and put a stop to it. They were arrested by Marshal Owens and placed in jail, where they spent the night. At their trial yesterday morning the jury hung and another one impaneled, which resulted likewise and the trial was set for Thursday morning at 10 o'clock, the prisoners being held in \$100 bond.

Ike Hubble: 13 Aug 1889

THE Marshal arrested like Hubble and Henry Robinson, colored, on the charge of stealing \$10 from Judge T. L. Shelton, but they proved that they found it and the judge was under the impression that he lost it on the street, so Judge Carson turned them loose. They had spent about \$10 of the money.

I lived there two or three years.

Louisiana

Of the slave states, Louisiana has the most complex history. The institution of slavery was established among indigenous populations in New France during the early 1700's by European settlers. Slavery continued under New Spain, then again briefly under New France and finally under the United States after the Louisiana Purchase in 1803. New Orleans became the most important slave market in the United States. Slavery was abolished in portions of the state under Union control in the state constitution of 1864. The rest were technically free based on Lincoln's emancipation Proclamation of 1863 although it was not in effect until occupied by Union forces.

Maryland permitted the practice of slavery from early settlement until the Civil War. Since Maryland was a free state, the emancipation proclamation did not apply. The new state constitution of 1864 under Article 24 prohibited the practice of slavery.




Figure 24: Manifest of 12 Negros, Mulattos and person of Color taken on board the Sloop General Pulaski by Josiah Hubbell of Baltimore, MD to be sold in Savannah, GA dated April 1826.

Missouri

Slavery in the Missouri territory began as early as the 1710s, when, as a colony of France, the French enslaved the indigenous Indian population and transported Africans to the colony to work. Slavery continued under Spanish control from 1762 to 1800 when France reacquired the territory. The United States bought the territory from France in 1803, and slavery was encouraged and allowed to expand up the Mississippi Valley. New Orleans became the hub of the African slave trade with over 1 million enslaved people involved in the domestic slave trade. As a border state, Missouri was exempt from the

Emancipation Proclamation of 1863. It was not until June of 1865 that a state convention approved an ordinance which abolished slavery, the same day the governor issued a "Proclamation of Freedom" which ended legal slavery in Missouri.

John appears in the 1840 Missouri census with 3 young boys <5; 1 male 10-15; along with he and his wife (1M20-30;1F20-30). He is also recorded as having, 3 slaves (1 male 24-35, 2 females 10-25). ME# Unknown. Margurette Hubble. from the 1840 Wayne co Missouri census she is head of household with 1M<5; 1F20-30 and 1F50-60. She also has 1 slave (1 male under 10).

Margurette has not been identified but she is possibly the same Margaret Hubble that appears in the 1850 census (b.1785 VA) but now living in Cape Girardeau, with no slaves. Margurette might be 2nd wife of Matthew Hubble (ME#950), Pegge Walker (Peggy being a nick name for Margaret). They were married in Missouri in 1811. Matthew and Peggy are mentioned again in a land exchange in September 1820. A Matthew Hubble married Katy Perkil in 1815 (same Matthew?). It's suggested by Ruth Ryan that Matthew died before 1832 leaving Peggy widowed with children. Or perhaps they divorced leaving children with Peggy while Matthew remarried. Another possibility is that this is an unmarried daughter of one of the three original Hubble settlers, born while they were living in northern Virginia. [see file Tt in the DesMoines Archives for more information on these early Missouri Hubbles].

ME#2420. John Hubble. son of William D (ME#1015) of KY and MO; b.1824 KY d.1902 MO. In the 1850 Liberty township, Clay co, Missouri census, John has 4 slaves (female 36, male 22, female 14, female 12).

ME#2422. Wm P Hubbell. son of William D (ME#1015) of KY and MO; b.1828 d.1898 MO. In the 1860 Missouri City, Clay co, Missouri census, he has 1 slave (female 14).

William next appears in the newspaper in 1897 when he became active in civil affairs. The article titled "Hall For Colored Folks", states that "an organization of colored people has been perfected for the purpose of building a large hall where all public gatherings of colored people may be held. The plan was evolved by George Fouche, a young colored man, who has been connected with various newspaper ventures, W. H. Hubble and others. Mr. Hubble lived in Kansas City for many years and still calls it his home. He is employed as interpreter at the Grand Central depot in the City of Mexico and is employed as guide by parties of sightseers who visit that city. He has been in the city on a visit for a week and helped perfect the organization. He returned to Mexico last evening and will stay there another year." [Source: Kansas City Journal 10 December 1897, p9].

In 1898 another article reports that, **W. H. Hubble**, a porter, was a member of an organization in Kansas City to get colored jurors to sit for jury duty. [**Source:** They Demand Equal Rights: A newspaper article dated 26 Feb 1898 in Kansas City, KS].

The last article about William appears in a black owned Kansas City newspaper called The Kansas City Sun. The article titled "W.H Hubbell, Pioneer" is the result of a reporter's investigation into the controversy as to who was the pioneer in the automobile business among colored people in Kansas City. "He ascertained that W.H. Hubble was the pioneer starting 1 May 1912 with the only car that was to be had by our people and the first to put into operation the automobile funeral service in this city which began 8 September 1913." The article continues, "W.H. Hubbell the pioneer who founded both the automobile funeral service and the pleasure car idea still leads with his Cole Aero Limousine service. [Source: The Kansas City Sun, 5 March 1921].




Figure 30: AF285 William H Hubble's ad for limousine service ca 1921

Slavery was abolished in the original 1802 constitution. However, with an eye on slave state Kentucky just across the river, some black laws were passed from 1804 to 1807 but rarely enforced until 1829. The city of Cincinnati became alarmed over the number of immigrant blacks and announced that black laws were to be enforced and to submit or leave in 30 days. A delegation was sent to Canada, as a result about half the black population moved to Canada. By 1849 with a change in political parties the black laws were modified and the monetary requirement removed.




Figure 33: AF312 Arch Hubbell 1940 Columbus, Ohio census




Figure 35: The sloop SS Mexico's slave manifest for George age 16. Shipper or owner is C.B. Hubbell. Dated January 1855

Virginia

The abolition of slavery in Virginia officially occurred at the end of the Civil War and with the passage of the thirteenth amendment. At first, freedom could only be enforced in areas occupied by the Union Army. Creating useful legislation was complicated by Virginia's two capitals (Richmond and Wheeling) and two constitutions. Many newly freed slaves moved to areas under control of the Army or to established free areas.

ME#464. Joel Hubble. s/o Justice (ME#150) of NY & VA; b.1771 NY d.1844 VA; See census versus tax records in figure D. The 1790, 1800 and 1810 census records have not survived. The Virginia tax records only list slaves older than 14 years old. Joel first appears in the county tax lists in 1791 (age 20) paying taxes on one horse. In the 1797 tax list Joel is taxed on three horses. The first documentation of slave ownership is in the 1800 tax lists; Joel (age 29) pays taxes on one slave and two horses. The 1798 and 1799 tax lists have not survived. Joel died in 1844. His

widow, Rachel, appears in the tax records in 1845 with five slaves and in 1846 and 47 with two slaves. In 1848 Joel's estate is paying taxes on 2 slaves. Joel's estate included a list of 9 slaves.

The identification of this William Hubell possibly could be ME#1015 William David Hubble, a nephew of ME#360 William Hubbell of Franklin and Scott Counties, KY. William was born in 1798 in Connecticut and before moving on to Missouri, he spent some years with his uncle in Kentucky where his first child was born in 1824. It's possible that William travelled from CT to KY with 3 slaves or acquired them along the way. It's possible he was enumerated in the 1820 census while travelling to KY; spending part of the year 1820 in Wellsburg. In the 1830 Franklin co, KY census he is recorded as having 3 slaves (See KY). There is no record of his slave ownership in Missouri; however, three of his children owned slaves in Missouri.




Figure 38: ME#5417 Thomas Hubble, 1870 Elk Creek, VA census




Figure 41: AF382 Adrian Hubbel, arrived in U.S. in 1913
