

your proposals for the 2009 reunion. Anyone may submit a proposal; you only need have a plan. The directors will review the proposals and announce the 14th Biennial site at the banquet in Frankenmuth. Our reunions appear harder to top with each passing year, but I know there are lots of places important to Hubbells we have not yet visited, so put on your thinking caps and send us your recommendations.

There has long been discussion about the possibility of finding Hubbell family (by any spelling) in England who can trace their ancestry to the same ancestor as the North American Richard Hubball. The link is still elusive, but not because Doug Poulter, our proud Asterisk, hadn't put forth the necessary effort. Doug, the descendant of an English woman named Hubble and her husband, has lived and worked in England and made contact with many of the families there who bear the name Hubble or one of its variants. For a number of years, he has been researching in the United Kingdom, and other Commonwealth countries such as Australia, New Zealand, and Canada to put together the pieces of the puzzle. He has assembled an amazing number of tantalizing possibilities, but to date has found no definite link between their families and ours. In late 2006, he published a book called *A Sojourn; The Hubbles of the United Kingdom & Other Commonwealth Countries*, which may be the key to uncover the link that spans the Atlantic. He is making the book available through the print-on-demand company, "Lulu" at www.lulu.com. You may purchase a copy by visiting that web site and the book will be in your hands in just a few days. I know you will enjoy reading this interesting book.

The next twenty-five years of THFHS belong to a new generation, perhaps our children, grand-children, cousins, or people we don't even know yet. Now, we are seeking candidates to serve as officers and directors who will lead us through the new challenges and successes. It's been said in every possible way but I'll say it again; the best way to get the most out of an organization is to participate in an active role when approached. But don't wait to be asked, go ahead and speak up. The satisfaction is great, and getting to know this special family is like nothing else. ### Treasurer's Report ~ Year End 2006

This report has three exhibits: Exhibit A-a Balance sheet for the USA Wells Fargo checking account; Exhibit B- Income and Expense sheet for the USA account; and Exhibit C-a combined Income, Expense, & Balance sheet for the Canadian checking account.

I have a few notes to share:

- 1. All Canadian checks for dues were deposited in U. S. A. Wells Fargo Bank checking account in USA dollars.
- 2. Dues dropped from \$8,360 in 2005 to \$7,296 in 2006. This may be partly explained by members who contributed to same amount each year but wanted part of their contribution earmarked for operations rather than only dues. Contributions to operations increased from \$945 in 2005 to \$1,432.50 in 2006.
- 3. Contributions to Hubbell Center in 2006 were about the same as 2005. They only appear to be higher this year because previously some members contributed directly to HC, but this year passed their contribution through the Society's books.
- 4. Contributions to the Scholarship Fund were about the same in 2005 & 2006. Balance in this fund 12/31/06 was \$2451.91. There were five \$1000 scholarships dispersed from the fund in August 2006.
- 5. Attached as an additional document for information only is Hubbell Center's statement of cash receipts and disbursements during calendar year 2007 and its cash balance at year end, and its comparison to year end 2005. I receive monthly reports from HC and believe members are interested in this information.

This completes my year end report.

# THE HUBBELL FAMILY HISTORICAL SOCIETY MEETING OF THE BOARD OF DIRECTORS FRANKENMUTH, MICHIGAN • SATURDAY, JUNE 24, 2006

As a quorum was present, the meeting was called to order at 8:03 A.M.

Directors Present: President Carol Hubbell Boggs, Vice-President Roger Hubbell (2007), Recording Secretary Dorcas Aunger (2011). Directors: Clifford Moses (2007), John Howard Hubbell (2009), Richard L. Hubbell (2009), Shara Simmons Hubble (2009), Nancy Moses (2009), Robert D. Hubble (2011). Marjorie Hlava (2007) arrived at the close of the meeting.

Committee Chairs other than Directors present: Program Chair Stuart V. Clark, Merchandise Specialist, Jan Fulton.

Directors Absent: Treasurer Peter Hansen, John Crowder (2007), Mary Ann Hubbell (2007), Nelson Hubbell (2007), Joan Hubble Bowden (2009), Robert G. Dawes (2009), Myrna Hubbell Kepford (2009), James D. Hubbell (2011), Lorenzo Hubbell (2011), Robert J. Hubbell (2011), Hilbert R. Hubble (2011), Kathleen VerKuilen (2011).

READING AND APPROVING MINUTES: Copies of the minutes of the second meeting of the Board of Directors, July 2005, were distributed. The members read them individually. The minutes were approved as corrected. The correction was the addition of the name of Cliff Moses to those directors absent.

[A copy of all the reports mentioned below was affixed to the file copy of the minutes]

TREASURER'S REPORT: In the absence of the Treasurer, Carol led us through the written report submitted by Peter Hansen. This report showed a balance as of April 30, 2006, of \$16,417.46 in the U.S. Account at Wells Fargo, and a balance in the Canadian account of \$3,989.12. The detailed report of income and expenses is affixed. The Treasurer's Report also included some comments regarding expenses.

In the ensuing discussion of the Treasurer's Report, Jan Fulton told about the increases in costs of shipping. Different methods of covering costs were suggested, including:

- (1) Using media rate
- (2) Notifying people that shipping may take longer if lower rates are used.
- (3) Putting in a line on the order form about shipping.

There was also a discussion about offering a bonus such as: if people order three books, they will only be charged shipping for two books. This will help lower our inventory.

It was moved by Robert D. Hubbell and seconded by Nancy Moses that we explore new shipping rates for merchandise, for books, and for inclusion on new forms, and that an electronic draft of a new form be sent to Carol Boggs, and to John A. Hubbell. The motion carried.

Jan Fulton will follow up on the above motion and make suggestions for changes in shipping rates.

The Treasurer's Report was then approved as submitted.

Finance Committee: (Roger Hubbell) The committee presented the proposed budget for the year. Roger reviewed the Income and Expense Comparison Sheet for the Current year to date and two prior years, which accompanied the Treasurer's Report. Carry over funds were not shown on that sheet, but are on the projected budget. A new item is listed, a fee for restocking merchandise. Some items not in the budget are the corporate registration fee, the web-site registration fee, and the cost of publication of the Hubbell Wives book, due to be published by the 2007, biennial.

It was moved by Cliff Moses and seconded by Shara Hubble that the budget be adopted as presented. The motion carried.

No additional work has been done on a potential dues increase, since the total of the carry-over funds increased. The directors commented that the membership fee has historically been kept low as an incentive to increasing membership, not income.

Carol reviewed the several plans of reorganization that have been considered both by Hubbell Center and THFHS. There are three different perspectives regarding what a foundation is. Roger stated that there is a need for stability in funding for both the Society and Hubbell Center. He emphasized that we need a method of continuing the support of Hubbell Center beyond what we receive on an annual basis.

Carol commended Roger for his work on the budget.

Nominating Committee: Nelson Hubbell has resigned as chair from this committee. Carol announced that Richard L. Hubbell has been appointed the new chair. Carol asked each member of the Board of Directors to recommend at least one person for him to consider.

It was moved by Roger Hubbell, and seconded by Shara Hubble, to accept Richard's appointment as Chair of the Nominating Committee. The motion carried. (Note: Subsequently, Richard had to decline his appointment and the Nominating Chair remains vacant).

#### REPORTS OF OTHER COMMITTEES

Genealogy Committee: Carol read Hilbert Hubble's report in his absence. She inserted a comment about Billy John's participation in the Y-DNA study, and the confirmation that his father was not a Native American. His origins are similar to those of Richard Hubball's descendents.

Tech-Com Committee: "Logan" Jim Hubbell's report was considered. Carol explained that "Open Office" is a free application that compares to MS Office and is compatible with both Mac and PC. In this report, Jim requested an allocation of \$100 for blank CD's and other miscellaneous supplies in order to create a digital library of our materials for archiving at Hubbell Center or elsewhere.

It was moved by Dorcas Aunger and seconded by Richard L. Hubbell, to grant \$100 to Tech-Com for this project. The motion carried.

At 10:20 A.M. a break was taken, followed by a tour of the Bavarian Inn Lodge facilities and lunch.

The board meeting reconvened at 1:12 P.M.

Membership Committee: (Mary Ann Hubbell) Carol read the report in the absence of Mary Ann. It shows a current membership of 357 paid members. In discussion following the report, it was stated that we should ignore the difference between the conversion of U.S. and Canadian funds.

Publication Committee: (John A. Hubbell) The first item considered was the proposal for the 25th Anniversary Booklet, which will be distributed at the 2007 Reunion. It will be about 32 pages in length, and in the same format as the Annual. Some topics to be included were suggested by the directors. The list included: Mantorville, Books published, a word search of Hubbell terms, Hall of Fame, Hubbell Center, Scholarship Fund, Hubbel Space Telescope Launch, trips to England, various reunions, Executive Committee and Board meetings around the country, the Web-Site, HubNet, Yahoo Message Board, Hubbell-L, "Hubbell Y-DNA surname project", short biography of Richard Hubball, Hubba the Dane, and recognition of past presidents.

Photos: Donald S., Harold B., presidents, plaque locations, trip to England, Rock Church, Warder Joe Hubble, Silver Tankard at Connecticut church, tree planting, White Hills Church, Ganado, Navajo Family, our Seal, a folder of Glasses from all the Reunions, Whitfield House in Guilford, Hall of Fame Recipients, Interior of Hubbell Center, Scholarship recipients or a list of them, Grant recipients (Hubbell-Bradley House).

It was moved by Roger Hubbell and seconded by Richard L. Hubbell, to authorize the publication of the proposed 25th Anniversary Booklet, with changes to be authorized by the Executive Committee. The motion carried.

The Board discussed the proposal for Graphtec Corp. to prepare our mailings. Nancy Moses asked to be contacted after she moves, and perhaps she may handle the folding and stuffing of future mailings.

Jan Fulton stated that she would revise the Merchandise Order Form that goes out in our mailings.

Hubbell Wives project: It was recommended that the committee talk with the Finance Committee about the binding of the book and also the feasibility of adding a pocket with a searchable CD in the back.

It was moved by Shara Hubble and seconded by Nancy Moses that the *Hubbell Wives* book be spiral-bound and non-hard cover, and that they consider the inclusion of a CD. The motion carried.

It was moved by Shara Hubble and seconded by Richard L. Hubbell, that the Society market Doug Poulter's Hubble Book. The motion carried.

A short break was taken at 2:30 P.M., and the meeting reconvened at 2:40 P.M.

Publicity Committee: (Shara Hubble) Shara told how she planned to put postings in societies on-line. She also suggested that we have magnetic bumper stickers or car window decals.

Hubbell Hall of Fame Committee: (Robert D. Hubbell) He passed the Hall of Fame Nomination form, and a sheet of Guidelines for Nomination. He stated that only one nomination had been received, so far.

Hubbell Center Board of Directors Meeting: (Robert D. Hubble) Robert distributed copies of the minutes of June 13, 2006. Jack Hubbell and Harvey Hubbell, IV are working on new bylaws and financial plan for Hubbell Center. The need to continue the digital recording of our records was reiterated. We need to reduce the volume of paper work stored at Hubbell Center.

Grants and Donations: The President stated that there had been no activity in this area this year.

Procedure Manual Ad-hoc Committee: Chair Kitty Ver Kuilen sent no report from this committee.

Hubbell Family Scholarship Fund: The President explained that since the fees had not been paid to renew the Corporation, the Secretary of State of Missouri had dissolved the Corporation. So in the interim the fund now becomes an ad hoc Committee of the Society until it becomes a standing committee of the Society, as planned.

It was moved by Roger Hubbell and seconded, to formally establish the Scholarship Fund as a Standing Committee of the Society. The motion carried.

It was moved by Cliff Moses and seconded by Roger Hubbell, that the committee be permitted to grant five \$1000 scholarships. The motion carried.

Merchandise Specialist: (Jan Fulton). Jan passed a sheet of recommendations. *The Legacy of Hubba the Dane* and the old Hubbell Baseball Cap are no longer in stock. 



### COETA LUCAS RECALLS A CENTURY

The Princess Suite at El Dorado Convalescent Hospital is filled with the laughter of good friends and the exchange of gossip and stories as Coeta Dell Gaffaney Lucas, seated on a golden couch, is being interviewed. Lucas, a 62-year resident of El Dorado County is a lucky woman; a woman with a wealth of friends and



loved ones, a great sense of humor and a 100th birthday party on April 29 to celebrate them both. [Coeta Lucas' mother was A&R 4603 Ella Maud Hubbell, daughter of 2446 George Thomas Hubbell. NY Giants pitcher Carl Hubbell, "The Meal Ticket", was her first cousin. –ed.]

Lucas was born in the Indian Territory in 1906 in a sod house dug out of the hillside, the daughter of a man who won 160 acres to homestead in the last land race. The Indian Territory became the state of Oklahoma in 1907 and the sod house was replaced by a wooden frame house that still stands.

Sandwiched between three older brothers and three younger ones, Lucas had her own special spot in the family. The brothers had many female admirers so Lucas had lots of friends who visited often, but she was also the obvious choice to be the lone Indian when her brothers wanted to play Cowboys and Indians.

At 5, her brothers lassoed their Indian sister who grabbed onto the windmill to avoid being dragged. The windmill cut off her thumb and every day for the next 10 days, Lucas was taken 10 miles to the local doctor to have the dressings changed and to be checked for infection. If she didn't cry, she earned a dish of ice cream. It was almost worth it.

The siblings formed a tight-knit company who worked as a team to make decisions, a trait Lucas would later bring to her work in Diamond Springs and El Dorado when she was part of a community effort to create a farm bureau and build a church.

"When we came to El Dorado and Diamond Springs, they were like little villages and everyone knew everyone," said Lucas. "They were lovable people in a lovable community. If one person had an accident, the whole community had it and helped out."

The family moved to California in 1926 after losing the farm in Oklahoma. "Just like the Grapes of Wrath" said Lucas. In church, she met Ralph Lucas, who made eyes at her instead of paying attention to the service and in 1928, they married.

"He was a jokester and a big tease, lots of fun," said Lucas.

Coeta, Ralph, and daughters Joan (Wigglesworth) and Gayle, relocated to the El Dorado-Diamond Springs area from Los Angeles in 1944. Living near an aircraft factory during wartime had made them feel uncomfortably like targets.

There were already a number of families from Oklahoma living in the area, families like the Arnolds and the Hamms, and it was easy to make long-lasting friendships. "

One of the longest lasting friendships has been with the Estey family and their three children, Billie (Gillett) 77, Darla (Hernandez) 67, and Jim Estey Jr., 66. They met on the first night the Lucases were in town.

"They were having a dance in Diamond Springs that Saturday night," recalls Lucas. "We were staying with relatives and during the supper hour a bunch of people from the dance stopped by. Jim Estey Sr. was all muddy and as soon as he saw me, a total stranger, he told everyone I had pushed him in the mud. Everyone thought it was very funny."

Margaret Estey, Jim Sr.'s wife, was also from Oklahoma and the families became the closest of friends. Lucas calls them her "half-relations".

The Lucases had a ranch and raised fruits and vegetables and Coeta Lucas also worked on the Ration Board during WW II. "Everything was rationed and there were different boards for each rationed item. Local people served on boards and decided whether applicants could have extra rations for shoes or gas or sugar."

The rural towns of El Dorado and Diamond Springs had no real place for people to socialize so business owners and community leaders, of which Lucas and her husband were a part, collaborated to build the Southside Farm Building located on what is now the fire station on Pleasant Valley Road across from Zachary Jacques restaurant. They also created the first Farm Bureau in El Dorado County.

"We had lots of fund-raisers and potlucks and if there wasn't any real reason to get together, we'd manufacture one," said Lucas. As an active member of the Farm Bureau, Lucas also worked hard to create and promote the El Dorado County Fair.

She learned to drive in 1962, so that she could get a job at the Quality Yardage Shop in Placerville where she worked for 14 years. An excellent seamstress, she made many formals for the Rainbow Girls and Job's Daughters she represented as a member of Eastern Star.

"As the girls and their friends grew up," said Lucas, "I made all their wedding dresses, and then I made their maternity clothes."

Ralph Lucas died in 1967 and Coeta did not remarry.

"I had to adopt my daughters' friends, because all mine passed on," said Lucas. "I've always horned in on them and their interests have been my interests."

Son-in-law George Wigglesworth jokes, "We never leave home without her."

Lucas, also known in the community as "Bobi" thanks to a grandson's rechristening, noted that it's fine to be her age if you have all your faculties, but not if you don't.

"At my age, I'm kind of a novelty in the hospital."

She is the oldest member of the El Dorado Community Church, a church she helped to build, and the place where she will have her 100th birthday party. One of her best party tricks is to introduce everyone at the party by name, a feat that she accomplished with more than 70 people on her 90th birthday. After the party her friends will take her out for her favorite - a lobster dinner.

"We used to take her out for lobster every five years, and then every three years and now we do it every year since she turned 90," said daughter Joan Wigglesworth.


"Now I'm so darned old, they'll probably take me to McDonald's," joked Lucas. "I've had a great life with good family and good friends that I can depend on. There's nothing I would do differently except make more wedding dresses."

### Citation for Professor Stephen Hubbell

Presented by Mark McKone, Professor of Biology and Director of Cowling Arboretum Carleton College Commencement, June 10, 2006:

"President Oden, it is a great honor and personal pleasure to present Professor Stephen P. Hubbell for the degree Doctor of Science.

"Professor Hubbell is a member of the Carleton class of 1963; he graduated magna cum laude and



"Professor Hubbell is among the most prominent ecologists working today. He has published widely in diverse areas of ecology but is perhaps best known for his work on tropical rainforests.

"Throughout his career, Professor Hubbell has contributed to both the theory and empirical data that address the great challenge of understanding how such high species diversity is maintained in tropical forests. In 1980, Professor Hubbell established a permanent plot of 50 hectares (120 acres) of Panamanian rainforest, and mapped, identified, and measured the size of every tree in the plot (more than 300,000 individual trees belonging to more than 300 species). Professor Hubbell's first effort now has blossomed into a network of such plots in rainforests across the globe, which is providing invaluable information at a time when the survival of these forests is under serious threat.

"Professor Hubbell also has made groundbreaking contributions to theoretical ecology. His 2001 book, The Unified Theory of Biodiversity and Biogeography, was immediately recognized as a leap forward in efforts to model the distribution and abundance of species in natural communities. His theoretical framework unifies concepts from diverse realms of ecology and evolution, and today remains at the forefront of contemporary debates on the nature of ecological communities.

"Despite his position at the peak of his career, Professor Hubbell has been generous in contributing his time to Carleton. He has spoke on campus several times in recent years, including a visit to my Tropical Rainforest Ecology class in 2002 that remains legendary."

#### Biography of Professor Hubbell--

Stephen P. Hubbell, Ph.D. (born 17 February 1942 [A&R 11198]) is an American ecologist on the faculty of the University of Georgia. He is author and proponent of the unified neutral theory of biodiversity and biogeography (UNTB), which seeks to explain the diversity and relative abundance of species in ecological communities. Dr. Hubbell is also a staff scientist at the Smithsonian Tropical Research Institute in Balboa, Panama.

Stephen Hubbell was born in Gainesville, Florida. He earned his doctorate in zoology at the University of California, Berkeley, in 1969. As a professor at the University of Michigan, he taught graduate courses for the Organization for Tropical Studies in Costa Rica. Later, at Princeton University, as a professor of ecology and evolutionary biology, he continued study of the population biology of tropical trees.

In 2003, Dr. Hubbell became Distinguished Research Professor in the Department of Plant Biology at the University of Georgia.

As a Fellow at the Pew Institute for Ocean Science, Hubbell initiated the establishment of the National Council for Science and the Environment (NCSE), which works with the parties that create and use environmental knowledge to influence environmental decisions.

Dr. Hubbell is married to evolutionary ecologist Patricia Adair Gowaty, who is also a Distinguished Research Professor at the University of Georgia.

## Edwin Hubbell Chapin, Universalist Minister

Edwin Hubbell Chapin (December 29, 1814-December 26, 1880), Universalist minister, author, lecturer, and social reformer, was one of the most popular speakers in America from the 1840s until his death. He was revered for his eloquent tongue and passionate pleas for tolerance and justice.

Edwin was born in Union Village, New York, to Beulah Hubbell [A&R 582, daughter of 190 Elnathan Hubbell, Jr.] and Alpheus Chapin. The Hubbells and the Chapins had emigrated from England in the mid-1600s and settled in Massachusetts and Connecticut. A non-puritanical Calvinist, Edwin's father played the violin, was a great conversationalist, and made his living as an itinerant portrait painter. His mother was a cultured woman from Bennington, Vermont. At 13 he joined a neighborhood drama club, where he recited poetry, sang songs, and played comic roles with relish.

His pious parents, fearing that Edwin would choose an acting career, enrolled him in Bennington Seminary. During his four years, Edwin blossomed into a witty, inspiring orator and poet. Although he could move an audience of townsfolk and fellow students to laughter and tears, no one predicted he would become a minister. After his graduation, he worked as clerk in the Bennington post office. As his employer and landlord was a lawyer, he began to think that he might want to pursue law as a career.

Chapin served eight months in two law offices in Troy, New York. While there, he enjoyed a stint as a political orator for Presidential candidate Martin Van Buren but disliked everyday legal drudgery. At the same time he was caught up in a religious revival. A Calvinist minister, thinking his ideas unsound, rebuffed his tentative application for advice about entering the ministry.

Depressed and discouraged, Chapin moved back with his family, who were then in Bridgewater, in central New York. From there he accompanied his father to nearby Utica. They lodged near the

office of the *Evangelical Magazine and Gospel Advocate*, a Universalist magazine. Wandering into its store one day, he was intrigued by the ideas in the books on display of a God of love rather than fear, so different from the deity of his Calvinist upbringing. After he began to work in a law office across the street, he continued to frequent the store. He wrote poems, hymns and editorials and was soon hired by the paper. He served as assistant editor, 1837-38. Converted by his exposure to the Universalist faith, he revived his desire to be a minister. In 1838 he delivered his first sermon in Litchfield, New York.

Although he had no college education or theological training, and only a year's exposure to Universalism, in 1838 Chapin was called to be pastor of the Independent Christian Church, in Richmond, Virginia, composed of both Universalists and Unitarians. Audiences flocked to hear the sermons and lectures of the young man with the powerful voice and magnetic personality. The same year, Chapin was ordained by the New York Central Association and married Hannah Newland of Utica, whom he had met at the *Magazine and Advocate* bookstore. She was his devoted companion for 42 years.

In 1848 Chapin was installed at the Fourth Universalist Society in New York City, where he remained for 32 years, preaching broad church Christianity and becoming the most popular preacher in the city. In 1852, when his congregation bought a larger church on Broadway, over 2,000 people came to the first Sunday evening service and hundreds were turned away. In 1866 the Fourth Universalist Society moved to a new building at 5th Avenue and 45th Street, The Church of the Divine Paternity.

Chapin's preaching was described as hypnotic. Although seldom controversial in his sermons, Chapin was adamantly opposed to slavery. Despite his abhorrence of war and loss of life, he supported the Union side during the Civil War.

Chapin appealed to a broad audience which included people from many faiths. He was not interested in theological differences, but in commonalities and in the spiritual aspects of religion. He rejected a literal reading of the Bible. He commended the moral principles set forth by Jesus Christ as the best path to salvation. He rejected eternal damnation, believing that each person would eventually be saved by a loving God.

Chapin preached continually on the obligation to care for all people, stressing their innate worth. In 1869 his congregation raised funds to establish, in his honor, the Chapin Home for the Aged and Infirm in New York City, open to anyone over 65. His wife was its first and long-time president. Bringing comfort and cheer to its residents was a favorite pastime for Chapin.

At ease behind a podium, Chapin was shy and uncomfortable in social settings. He preferred the company of family and close friends (such as P. T. Barnum), where he was relaxed, witty, and jovial. He rarely visited parishioners, except the sick or grieving. He disliked small talk, and quickly disappeared after services and lectures to avoid meeting strangers and autograph seekers. Fortunately, his wife Hannah was even-tempered, cheerful, sociable, and a skilled manager of her husband's business affairs.

Chapin preached his last sermon on Palm Sunday, 1880. His health had deteriorated for six years from progressive muscular atrophy, but he refused an assistant and resisted retirement until forced by debilitation. After a brief trip to Europe and a summer relaxing at the family cottage in Pigeon Cove, Cape Ann, Massachusetts, he steadily grew worse and died a few days before his 66th birthday.

# Passports Needed to Cross US - Canadian Border

We'd like to remind our Canadian cousins planning to attend the 13th Biennial Reunion and THFHS 25th Anniversary in Frankenmuth, Michigan, that they will need their passports if entering the US by AIR travel.

This new regulation became effective January 23, 2007. Currently, Canadian visits by sea and land border crossings into the US require proof of citizenship and identity such as: Drivers' license or other type of government issued identification; or Birth certificate. As of January 1, 2008, a passport will be required to cross all land borders as well as air and sea travel.
